

### President's Message

Welcome to the December issue of the Malamute Mail and my first message in the role of President.

Melbourne Royal has come and gone, and this year again saw a very disappointing entry. This may be due in part to the shift of our Championship Show away from the Royal, which won't be



the case next year. Congratulations to Hayley & Rebecca French-Davis and Kataku Kennel's Bond *Sup Ch Kataku For Yr Eyes Only* for not only taking out Best of Breed, but also Best In Group.

Unfortunately I was not able to get to the Championship Show this year, but all feedback has indicated that the event was very successful and enjoyed by the exhibitors and Judge alike. Thanks to our Show Secretaries past and present, Lorraine and Dale Green, for their hard work which made this event such a success. Thanks also to our sponsor for this event CANIDAE, and a special thank you to Anna Paxton who hosted our Judge, Arie Schwarz during his visit.

Congratulations to the winners and placegetters on the day, particularly to Shelley Turner and Rebekah & Hayley French Davis on Iggy *Ch Hamalek Cruze Control (AI)* taking out Best In Show, and to Brett White's *Blaze Whitewarrior Southern Blu (AI)* for RUBIS. Our weight pull events have enjoyed a good entry all year, but the Tuggy Shield event attracted a massive entry of 26 dogs which is fantastic. Many of the competing dogs were Am Staffs, Am Bulldogs and Staffies, but nevertheless there was hot competition amongst the Malamutes, with McPhan's Darcy *Tanome Against the Grain* eventually winning the Shield with a weight to weight ratio of 23.4, and Brad Acht's Shadow *Kataku All Shadow* pulling the highest weight with a massive pull of 916 kg. Not to be outdone, Am Staff Mack, owned by Eliza Perry, pulled a massive 1006 kg with a weight to weight ratio of 32.7, making him the overall event winner.

Thanks to Mel Gray, husband Alex and all those who helped run the weight pull events throughout the year.

We have seen a revision to our Club Rules, passed at our September General Meeting and approved by Consumer Affairs Victoria on 9 October. The changes bring our club rules more into line with the Model Rules for Incorporated Associations and into compliance with the Associations Incorporations Reform Act 2012. Other changes include the introduction of a subrule permitting the use of technology for "attending" committee meetings, which is important give our Committee are spread across Victoria and are not always able to come along to Committee Meetings, and non-executive Committee members no longer needing to be VCA members.

On that topic, I would like to thank those who put their hand up to be on Committee for this term. It is good to see a revival in interest and we are fortunate to retain and welcome back Committee members with many years' experience on the Committee. Following on from Ian, who has been in the role now for over 10 years, will not be easy, but I am hoping there won't be too many unexpected "challenges" this year. If there are, we have a good team together to make the best of whatever comes our way.

Unfortunately we have already had two members leave our Committee, so we thank Sharon Easton and Vic Young for giving it a go and wish them all the best with their many other pursuits. Shelley Turner has been appointed by the Committee to take over the VP Breed Welfare role, E'vette Levett is now Newsletter Editor, and thank you to Matthew Hutton for accepting the position of Fundraising Coordinator. Summer brings its share of concerns including grass seeds, heat, snakes and fires, so please take particular care over the next few months. Have a safe and wonderful Christmas and enjoy your Mals!



## Sledding update

Our final sledding event for 2014 was our Training Day held on Sunday 26 October at the You Yangs. A number of eager-beavers camped overnight and got their dogs out for a run Saturday night and early Sunday morning and thoroughly enjoyed themselves.

The official fun started at 8 am, with a team passing training exercise. Four teams participated: Joe Neeleman's 3 dog Malamute team, Matthew Hutton's 2 dog Malamute team, new member Geoff Eberle with his brand new, never before tried 1-dog Malamute team, and Terry O'Connor's bomb proof 1-dog Siberian Husky team. We covered a short one kilometre course in approximately an hour, the teams leap frogging each other at slow speed. The musher ran beside the team, giving commands, providing corrections when required, praise when earned, and generally managing their dogs when in close proximity to the other teams. A handler rode the rig/scooter and just enjoyed the run (just ask Jennifer Cornell, who after coming to races for years got to enjoy her first ever run with a team and was still beaming at days end).

Each dog ran wearing a correction collar with a short lead enabling corrections to be provided when required, and by the end of the run we had all teams running bunched up, at times 3 abreast, and passing each other without interference. And we also had some very happy mushers.

The rest of the day saw lots of new faces and happy dogs trying out short mushing runs, socialising, checking out equipment and having great fun. As usual, it was fantastic to see happy smiling doggy and human faces as they tried out a harness and scooter for the first time. Matthew Hutton, Joe Neeleman and Jennifer Cornell put on a barbecue lunch as a fundraiser (thanks guys, not just for the BBQ but for your help thoughout the day!).

Thanks also to Ralph and Sandy Koch, Stuart Vanderpol, Colin and Sharen McPhan and everyone else who helped out.

Our first sledding event for 2015 will be a training weekend sometime in April, where hopefully we'll offer team training again, hopefully more than once, and hopefully with more teams.

# WHY *NOT* TO CLIP OR SHAVE ALASKAN MALAMUTES OR DOUBLE-COATED BREEDS

When warmer temperatures arrive, many Malamute or arctic breed owners explore options on how to help their dogs stay comfortable. Clipping or shaving the coat is often wrongly considered by owners and even recommended as an option by some vets or groomers who don't know any better when they should. For some coat types where dogs don't shed their fur, this is an ideal solution but not for those double-coated breeds that do shed their coat and definitely NOT for your Malamute or arctic breed.

With the exception of hard-coated terriers, dogs come in one of two coat types: single-coated and double-coated.

Examples of single-coated breeds are Poodles, Shih-Tzus, Maltese, etc. This type of coat will continue to grow longer and longer, much like human hair, with genetics being the final determination in reference to length

Double-coated or fur-bearing breeds have coats that grow to a predetermined length. They can be further separated into open coats and closed coats. These breeds have a hard, protective outer coat (guard hairs) and a soft, dense undercoat. Examples of open, double-coated breeds are any of the Spitz-type breeds, such as the Alaskan Malamute, Siberian Husky, Samoyed, Akita, Chow Chow or Keeshond

This coat is designed to shed snow or ice and provide maximum protection against freezing weather. The guard hairs protect the dog in both winter AND summer by helping to regulate their body temperature. Removing the dead undercoat in summer is very important as it helps with allowing proper air flow to get to the skin. However, shaving or clipping can actually cause overheating, sunburn and heatstroke.

Closed, double-coated breeds have noticeably longer guard hairs, which lay down over the undercoat, sort of like a blanket. While the outer, or guard, hairs get wet, the undercoat works to keep the dog's skin dry. Examples include Golden Retrievers, Australian shepherds and Newfoundland's

Single-coated breeds can be clipped down to the skin, and the coat will grow back pretty much as it was before. The same is NOT true f or Malamutes and double-coated breeds. For this reason, shaving these dogs down is not a solution to summer heat.

Think of a healthy double coat as an old -growth forest. There is a balance with different parts providing different benefits. If you clear -cut an old growth forest, there will be immediate regrowth of a lot of young trees very soon.

Unfortunately, they won't initially be the same kind as those you cut down. Instead, the forest has to start from scratch and spend decades, first growing ground cover and softwoods that provide an environment for slower growing hardwood varieties. It takes generations before the natural balance is restored.

While on a much shorter timeline, it's the same thing with a double-coated dog. Guard hairs represent old growth, and undercoat represents ground covering vegetation. The act of shaving a Malamute or double-coated breed removes the dog's natural insulation and causes their system to kick into high gear. They'll now produce coat to protect themselves from extreme temperatures, sunburn and sharp objects.

Since the top coat or guard hairs take a LONG time to grow, what the dog's body produces first is soft undercoat. That's why we hear people say, "I shaved my dog and it grew back twice as thick and really fuzzy!" If it's not brushed regularly and often, it will also often grow back matted. In reality, what happens is that the original coat isn't restored at all. What grows in instead is thick, prolific undercoat mixed with short new guard hairs. It is called 'false coat' or 'coat funk'.

So, why is this bad? Picture this scenario:

It's hot outside. You're getting dressed to go outside and work in the yard. Are you going to put on light clothing and sunblock or thermal underwear and a woolen jumper? A dog's shaved-down false coat is like that jumper. It's dull, soft and soaks up water like a sponge. Burrs and foxtails stick like Velcro. Above all else, it's way too thick for hot weather. By the time that false coat grows out enough to protect the dog from sunburn, scrapes and bites (the usual job of the top coat), it is so thick that the poor dog might as well be wearing thermal underwear and a jumper.

Remember, Mother Nature designed the undercoat to be extremely heat-retentive. Some people don't realise that dogs don't regulate their temperature through their skin like we do and a Malamute's coat is designed to keep them warm in winter and cool in summer. There are specially designed undercoat rakes to use for removing the dead undercoat... if you use them weekly as well as a brush or every second day when they are blowing their coats there would be no need to even consider any other option.

Do you take your dog to a grooming salon? You can request a bath and blow-out. Virtually all grooming salons have high velocity blow dryers in their work areas. These powerhouses can literally blast the dead undercoat out of y our dog's hair after a thorough bathing with far less brushing and combing needed afterwards. Alternatively, you can purchase your own dog blower dryer.

The benefit to your dog is a healthy, balanced coat you can both live with. Sure, you could be lazy, not care about the high risks and opt for the shave-down, but you'll more than likely be back in a month or so for another "shave-down" because your dog is cooking in its own hair. Then, if you're like most owners who fall into this cycle, you'll intentionally let your dog's woolly false coat grow out all winter "for warmth," only to have it shaved off again in the spring. In reality, all winter long while you're under the false notion that your dog is staying warm and dry under that thick layer of fuzz, his coat is matting, retaining water and mud and possibly even mildewing. It will stay cold and wet for hours. Do you see the vicious cycle that started?

In some cases, owners really don't have a choice if it is a 'medical necessity'. Same applies if the coat is so matted and skin has become infected with burrowed grass seeds or bacteria creating multiple hot spots from being moist all the time and not even brushing out under anaesthetic is an option and only then that shaving is truly the most humane option, affording the owner a chance to start over and greatly improve their brushing skills and consistency of frequent grooming..

These are situations to consider first so you can make an informed decision if a vet or groomer recommend clipping or shaving, but please be a ware that MANY vets and groomers are not informed about the dangers of clipping or shaving a double-coated breed and in fact far too often erroneously recommend it to the detriment of the poor dog.

However, if your sole motivation for shaving your dog in the spring is to "keep him cool," you need to know that you're actually creating a far worse situation for the dog than you think. There are high chances the coat will grow back even thicker each time, patchy, take many months or unfortunately.... not grow back at all. Aside from destroying coat integrity, shaved dogs are susceptible to a multitude of complications, including, but not limited to, alopecia, heat stroke and skin cancer, specifically Solar-induced Squamous Cell Carcinomas and Dermal Hemangiosarcomas.

Sometimes, these complications are not reversible.

The only time it would be acceptable to 'trim' a dog is if they have a long and woolly coat. Trimming the bottom of the hocks on back legs to prevent burrs from sticking to their wispy bits than hang down could be helpful or trimming the underbelly if very long... but only to an acceptable level.

Trimming around the feet if fur is long around the nail area and hanging on the ground is also okay, as well as regularly trimming under the pads, where fur often gets long and causes them to slip on tiles and vinyl floors – allowing them to get a better grip – this is acceptable and recommended, especially for those with joint problems and senior dogs.

To keep your Malamute or double coated breed cool in the summer, it is crucial to ensure you rake and brush out as much as possible of the dead undercoat on a regular basis. If you can't keep them inside in air-conditioned comfort, make sure there is plenty of shade and fresh water available with a small pool for them. You can buy children's hard plastic sandpit shells for this purpose.

On hot days, you can wet their feet and bellies, put ice blocks in their water or put a wet towel down for them to lie on. Give frozen treats or bones. Remember to never walk or exercise them in the heat, only very early in morning or late in evening and keep them off asphalt and paths to prevent burnt paws and never, ever leave them in a warm or hot car for any length of time.... even with the windows down.

On really hot days, many people like to wet their dogs down completely. Please don't do this with Malamutes. Their coats are more likely to trap moisture, creating a warm, moist and humid environment within the coat, making the dog more uncomfortable and promoting bacterial or fungal growth, resulting in painful 'hot spots'. If you do decide to wet them down, take them swimming or even when bathing – it is crucial to ensure the undercoat is as dry as possible or preferably blow dried.

- (d) to promote the holding of Exhibitions under the VCA Inc. Rules and Regulations and to conduct Exhibitions and/or to promote Obedience training and to conduct Obedience Trials, Tracking Tests, and Field Trials;
- (e) to foster, promote and protect the interest of exhibitors of dogs at exhibitions and particularly the exhibitors of Alaskan Malamutes
- (f) to collect, verify and publish information relating to dogs and the breeding and exhibition of dogs;
- (g) to educate and encourage members, breeders and judges to abide by the requirements and standards approved by the VCA Inc. for the conduct of Exhibitions and Shows;
- (h) to promote good fellowship and sportsmanship amongst members and those participating in or attending at Exhibitions and Shows;
- to inform members of and make known to them the Laws and Regulations of the State relating to the ownership and care of dogs, and the responsibility of owners for the conduct and actions of their dogs;
- (j) to hold functions and lectures relating to dogs and to the purposes of the Club generally;
- (k) to provide awards and donate prizes for competition at Exhibitions and for the competition by breeders and exhibitors of dogs;
- (I) to foster relations with other Clubs and bodies having similar aims;
- (m) to promote and assist worthy causes, as agreed at a General Meeting of the members of the Club;
- (n) to the invest the funds of the Club not immediately required in such manner as the members or the Committee in lieu thereof shall determine;
- (o) to purchase, hire, lease, etc. and do such things as are conductive or incidental to promoting and achieving the purposes of the Club;
- (p) to carry on such other activities or promote or encourage interest in the breeding, upkeep and training of and the general well-being and improvement of Alaskan Malamutes and to do all such other things as may be necessary or conductive to carrying out the objects of the Club.

Rule 3(1): INTERPRETATION

"Act", means the Associations Incorporation Reform Act 2012 and includes any regulations made under that Act.

"Chairperson", of a general meeting or committee meeting, means the person chairing the meeting as required under rule 19(6);

"Committee Meeting", means a meeting of the Committee held in accordance with these Rules;

"Committee Member", means a member of the Committee elected or appointed under Rule 28;

"Disciplinary Appeal Meeting", means a meeting of the members of the Association convened under rule 23(3);

"Disciplinary Meeting", means a meeting of the Committee convened for the purposes of rule 22;

"Disciplinary Subcommittee", means the subcommittee appointed under rule 20;

"General Meeting", means a general meeting of the members of the Association convened in accordance with Part 4 and includes an annual general meeting, a special general meeting and a disciplinary appeal meeting;

"Member entitled to vote", means a member who under rule 30 is entitled to vote at a general meeting;

"Officers", for the purpose of these Rules, has the same meaning as is ascribed to the word "Office Bearers".

"Special Resolution", means a resolution that requires not less than three-quarters of the members voting at a general meeting, whether in person or by proxy, to vote in favour of the resolution;

"The Registrar", means the Registrar of Incorporated Associations.

- (6) Upon a nomination an application being referred to the Committee, the Committee shall determine whether to approve or to reject the application.
- (7) (a) Upon a nomination an application being approved by the Committee, the Secretary shall enter the nominee's applicant's name in the register of members and upon the name being so entered, the nominee applicant becomes a member of the Club.

### The Dangers of Grass Seeds and Plant Awns

Summer is finally here and many of us are taking our dogs for lovely long walks through fields and woods. But at this time of year Vets start to see a lot of patients (particularly dogs), with grass seeds and plant awns embedded painfully in various parts of the body.

During hot summery conditions grasses and plants start to dry out and their barbed seeds begin to scatter. These can cause major problems for our dogs (and occasionally other pets), who often get these seeds caught in their paws, nostrils, ears, eyes skin and any orifice, including genitals. The problem is that these seeds have 'one-way' barbs that allow the seed to work its way through the fur, in one direction only, and then into the skin of the animal. If they are not found and removed quickly, these seeds have been known to work their way through the skin and end up causing serious problems as they migrate further into the body.

The most common places we see grass seeds or plant awns <a href="Paws">Paws</a> – The grass seed gets hooked into the fur, especially in the groves between the toes on top of the paw and the between the pads beneath the paw, and then starts making its way toward the skin. It can then penetrate the skin and burrow

deeper into the tissue leaving a tract (narrow tunnel) behind. The first sign of this is usually persistent licking and/or nibbling between the toes or of the whole paw because the grass seed causes pain, discomfort, swelling, inflammation, lameness and infection.

<u>Ears</u> – Grass seeds that get caught in the ear hair can soon make their way down the ear canal and end up next to the very delicate ear drum. The signs of this are usually pawing of the ear, head shaking, rubbing the head/ear on the ground and also inflammation (redness) of the ear flap. If left the grass seed may penetrate the ear drum and cause worse problems,

 $\underline{\textbf{Nose}}$  - Grass seeds are sometimes inhaled by the animal and then get lodged in the nasal passage. The signs of this are usually sneezing or snorting, pawing at the nose and some nasal discharge.

Other less common places can include the eyes where the seed causes irritation to the surrounding area or even penetrates the eye itself. Or the mouth, where the seeds can get lodged in the gums or throat, causing irritation, pain and discomfort. From here the seed could travel down into the body causing abscesses and damage to internal organs or vertebrae.



### Removal of grass seeds and plant awns

If you are lucky you may find the seed as it is just starting to penetrate the skin. These can usually be pulled out gently with some tweezers and the wound can be bathed and treated with an antiseptic solution.

Once a grass seed has penetrated the skin the process becomes much more difficult. Because they are vegetable matter, grass seeds and awns will not show up on an X-ray and can be very difficult for the vet to locate; it is often like searching for the proverbial needle in a haystack. In most cases the patient will need a heavy sedation or a general anaesthetic before the vet can remove the seed because of the pain and inflammation caused.

When removing seeds from the ear canal the vet uses the otoscope to look down the ear canal and a pair of sterile crocodile forceps (pictured), which are narrow and long and have a grasping mechanism that can be used to remove the seed once it has been located.

For seeds in the paws and skin, the vet will again use the crocodile forceps by inserting them into the tract left by the seed as it entered the skin, unfortunately because the seed

cannot be seen this is often a very frustrating procedure for the vet, and may require several attempts with several anaesthetics for the pet.

### Prevention is better than cure!

- Be particularly vigilant at checking your pet's coat for grass seeds, plant seeds and burs that may become entangled in the hair.
- Daily grooming will help remove any attached seeds and help you check for any suspicious looking areas or wounds.
- Keep hair around the feet, foot pads and ears trimmed short if possible, as this will help prevent grass seeds attaching.
- Avoid walking in areas with long grasses during this time of year.
- Don't allow your dog to chew grasses that have seed heads on them.
- If your pet is showing any signs of discomfort, such as licking, lameness, head shaking, excessive sneezing, coughing etc. or if you find a wound that you suspect could be from a seed take them to the vet as soon as possible. The quicker we can remove the seed, the less damage it will do.

### **Puppy & Referral Service Report**

Puppy Register – no registrations received.

Referrals – there have been a few people enquiring via email and application form re: adopting a Malamute which have been referred on to appropriate people.

There has been an unprecedented amount of abandoned pound dogs and surrendered Malamutes or their crosses to rescue groups in the various states. NSW currently have close to 40 Malamutes/Mal crosses with most all kennelled in Mandalong due to the inability to obtain any foster carers in NSW.

A new group has been set up this year in Queensland. SHAMROQ (Siberian Husky and Alaskan Malamute Rescue of Queensland). 25-30 of their current dogs are Malamute or Mally crosses with more in pounds, awaiting foster care. Foster carers are really what they are most in need of right now!

Victoria has at least 15 Malamutes or Mal x's from various rescues or impounded in pounds or shelters. AMRAA have had to resort in recent times to utilising kennelling due to the inability to source foster carers as well. Foster carers are crucial to the ability to be able to rescue more Malamutes.

There has been no 'quiet' period the past few years and the busiest time of the year is just starting.... a difficult and overwhelming period for all rescues. Malamute rescues are in DIRE need of more supporters and helpers with either offers of foster care, assistance with food or products, donations of items or financial assistance. Assisting by providing much needed exposure by sharing on Facebook/twitter or printing out pamphlets of the dogs and putting up in your local area is easy and a very worthwhile, extremely valuable way to help. Please consider helping in any way possible, those of our beautiful breed who are currently in need at the moment.

### Newsletter



### Heatstroke signs



### Symptoms

- · Increased heart rate
- · Excessive panting
- Increased salivation
- · Bright red tongue
- · Red or pale gums
- · Thick, sticky saliva
- Depression
- · Weakness
- Dizziness
- Vomiting
- · Diarrhoea

### Prevention



- Don't leave your dog in a car unattended at any time.
- Restrict exercise activity in hot weather.
- Avoid hot sand, concrete or asphalt areas where heat is reflected and there is no access to shade.
- Place a circulating fan near your dog to cool him down.



- Always give your dog access to drinking water.
- Ensure outside dogs have access to shade.
- Wetting down your dog with cool water or allowing him to swim can help maintain a normal body temperature.

### Heatstroke first aid



- Remove dog from heat immediately – preferably into an air conditioned building or, at the very least, into the shade.
- Wetting down the area around your dog can also help to lower the ambient temperature.



- Lower temperature by wetting with cool but not chilled water and setting up a circulating fan.
- Check rectal temperature every five minutes using a digital thermometer and continue cooling process until temperature drops to around 39\*.
- Caution: cooling too quickly can cause complications.

### You should always see a vet



- Even if your dog appears to be recovering, take him to your vet as soon as possible. He should still be examined since he may be dehydrated or have other complications.
- Caution: if your dog is displaying severe signs of heat distress, get him to the vet as quickly as you can.


### Beware of Toxic Festive Food


The Australian Veterinary Association (AVA) is advising pet owners to be careful about the kind of leftovers they feed their animals during the Christmas period.

"Vets treat many pets with digestive problems during the Christmas period," says Dr David Neck from the AVA. "There are some foods that we indulge in over the Christmas period that are just not good for our cats and dogs," he said.

The AVA has a list of common foods that can cause potentially fatal health complications for your pet:

- Chocolate toxic to dogs and cats, even in small quantities
- Nutmeg dogs that have ingested nutmeg can suffer from tremors, seizures, issues with the nervous system and even death
- Avocados contains a dangerous toxin which can damage the heart, lungs and tissue of many different animals





- Grapes and raisins can cause acute kidney failure
- Macadamia nuts can be toxic to dogs. Symptoms will likely occur within 12 hours and can include vomiting, hyperthermia and elevated heart rate
- Others include dairy products, raw eggs, mushrooms, raw fish, citrus fruit, green potatoes & large quantities of tomatoes or salt.

"The best treat you can give your pet over Christmas is quality pet treats from your vet clinic, pet store or supermarket that contain the right nutrients to keep them healthy," he said.

\*\*If you suspect your pet has eaten something toxic you should contact your veterinarian immediately\*\*

### **Cone Degeneration (CD)**

Cone Degeneration (CD) is actually relatively rare in Alaskan Malamutes and is caused by a distinct mutation in gene CNGB3. It causes day blindness due to the degeneration of the retinal 'cones', cone-shaped cells in the retina that respond primarily to bright daylight.

The retina of an affected dog initially appears normal when examined by an ophthalmologist, as does the electroretinogram (ERG). However, the ERG response from the degenerating cones declines with age and is non-recordable once a CD-affected dog reaches maturity.

In contrast to Progressive Retinal Atrophy (PRA), which is the more common type of retinal disease in many dog breeds, CD does not affect night vision. A second type of cell in the retina, the 'rods', rod-shaped cells that respond primarily to dim light and detect movement, are not involved in this disease. The CD-affected dog retains the ability to see at night or in dimly lit areas.

CD is an autosomal recessive condition and we can now 100% reliably identify the genotype of each dog through the use of a DNA test that has been developed by Optigen in the US.

A CD tested dog will fall into one of three categories:

- Normal (N) genetically clear, non-carrier or, more formally, homozygous normal.
- Carrier (C) heterozygous.
- Affected (A) homozygous for CD.

(Homozygous means that both copies of the gene are the same (either both normal or both CD) whilst heterozygous, the carrier, means there is one normal and one CD.)

A 'normal' will never develop CD and can only pass on the normal gene to all their pups, meaning none of the pups can ever be 'affected'. Even if you breed a 'normal' to a 'carrier' or an 'affected', the pups can only ever, at worst, be carriers themselves and, therefore, will never suffer from CD and, provided they are tested and, if found to be carriers, put only to clear dogs, will not produce affected stock either.

**SYMPTOMS:** The condition can be diagnosed very early in an affected dog's life as, between 8 and 12 weeks of age, when retinal development is normally completed, signs of vision problems are noticeable. Affected pups become day blind and are photophobic, they find exposure to bright light to be irritating and will shun brightly lit areas, though vision in dim light remains normal.

A CD affected dog can lead a normal life in virtually every way, except that special consideration needs to be given in well-lit environments where help may be needed in negotiating obstacles, though dogs will readily learn to adapt to their condition. Additionally, care must be taken not to 'surprise' the affected dog (for example, the sudden face-to-face approach of another dog) as this may lead to an unexpected reaction).
