

What is zinc-responsive dermatosis?

This disorder causes scaling and crusting of the skin. It is not due to a dietary deficiency of zinc; instead affected dogs appear to have a higher than normal requirement for zinc, perhaps due to abnormal intestinal absorption. As the name implies, the skin condition improves with zinc supplementation. Young fast-growing puppies of large breeds such as Doberman pinschers and Great Danes sometimes experience a similar condition due to a transient zinc deficiency.

How is zinc-responsive dermatosis inherited? The mode of inheritance is unknown.

What breeds are affected by zinc-responsive dermatosis?

Alaskan malamute, American Eskimo dog, Samoyed, and Siberian husky. Young rapidly growing Doberman pinschers and Great Danes sometimes experience a similar condition due to a transient zinc deficiency.

For many breeds and many disorders, the studies to determine the mode of inheritance or the frequency in the breed have not been carried out, or are inconclusive. We have listed breeds for which there is a consensus among those investigating in this field and among veterinary practitioners, that the condition is significant in this breed.

What does zinc-responsive dermatosis mean to your dog & you?

Signs are usually first seen around puberty. There is reddening, scaling, crusting, and hair loss on the muzzle and around the eyes. The footpads as well as the area around the vulva and anus may be affected. The lesions are itchy in about half of dogs with this disorder, causing chewing of the feet or rubbing or pawing at the face.

How is zinc-responsive dermatosis diagnosed?

The diagnosis is made through a skin biopsy. This is a simple procedure done with local anaesthetic, in which your veterinarian removes a small sample of your dog's skin for examination by a veterinary pathologist. The biopsy will show changes characteristic of this condition.

How is zinc-responsive dermatosis treated?

Temporary zinc supplementation is effective in treating the transient zinc deficiency that may occur in young rapidly growing Great Danes and Doberman pinschers. Affected dogs of the Northern breeds must receive dietary supplementation of zinc for life, or the signs will recur.

Breeding advice

Affected dogs and close relatives (parents, siblings) should not be bred.

Classes on offer will be: < 36kg, 36kg – 45kg, 45kg - 55kg, Unlimited The requirements of the AMCV Weight Pulling Rules apply – copies are available from the Weightpull Co-ordinator or website www.amcv.org.au.

Eligibility

For a dog to be eligible for the Annual Weightpull Class Titles and Top Weightpull Dog of the Year award, the following applies:

- the owner/handler of the dog must be a current financial member at the time of the event for that result to be eligible, and must be a member at the conclusion of the annual competition.
- the dog must be a purebred ANKC registered Alaskan Malamute;
- the owner/handler must provide the dog's registered name and registration number on the entry form.

In addition, to constitute an event in a class there must be a minimum of two (2) eligible competitors in that class. If, during the course of the year, there are less than two (2) eligible competitors in a weight category no award will be given, however that dog may still be eligible for the Top Weightpull Dog of the Year award.

*Subject to amendment in the event of changes to the event schedule.

Class awards will be determined on the basis of a dog's highest three (3)* weights pulled in that weight class out of the maximum five (5) eligible events*. A dog that has competed in less than three (3) events is <u>not</u> excluded from eligibility for class awards. Annual awards will be provided for 1st, 2nd and 3rd place in each eligible weight class. In the event of a tie, a joint award will be provided.

Top Weightpull Dog of the Year Award

The Top Weightpull Dog of the Year title will be awarded to that dog that has achieved the highest combined weight/weight ratio calculated from that dog's best three (3) results* achieved in any of the weight classes from the five (5) eligible events*.

Results will be calculated to 2 (two) decimal places.

In the event of a tie a joint award will be provided.



Backpack Hire: \$5.00 per day – please contact the co-ordinator to per book a club backpack.




It is important that you arrive early to allow enough time to weigh in your dog and get ready: Please load and weigh your dog's backpack to roughly the correct weight at home to save time when you arrive.

Who can participate: DOGS MUST BE A MINIMUM OF 12 MONTHS OLD TO PARTICIPATE IN THE HIKE. Dogs must be 18 months old to carry weight to the Working Pack Dog title standard. One dog per handler recommended. You don't have to walk the entire distance, and your dog does not have to have a backpack or carry the entire weight.

Temperature restriction: EVENTS MAY BE CANCELLED IF THE FORECAST TEMPERATURE IS OVER 25°C: please contact the Backpacking Co-ordinator the day before the hike.





There will also be some working-dog and Malamute related items for sale, however if you are interested in purchasing a particular item, please email the AMCV prior to the event.


Directions:





Never feed your dog these foods...

It's no secret that most dogs love food. While giving in to those hopeful eyes and sharing food from your plate may seem tempting, it is important to remember that there are some human foods that need to be avoided at all times.

The foods listed below are highly toxic to canines and even small doses can make your dog very sick or in some cases can be fatal. If you do keep these foods in the house be sure to store them well away from curious noses and remind guests (particularly children) to always ask before feeding anything to your pet. If you suspect your dog has consumed any of the foods listed below please seek veterinary assistance immediately.

Chocolate


Chocolate contains theobromine, a chemical that acts as a cardiac stimulant and can affect



the lungs, kidneys and central nervous system. Just like humans, chocolate is very appealing to dogs and it is one of the most common causes of canine poisoning, particularly around holidays such as Easter and Christmas. The level of toxicity relates to the type of chocolate, with milk chocolate being the least toxic and dark chocolate the most, due to the higher levels of cocoa. Small amounts of chocolate can cause vomiting, diarrhea and unusual levels of thirst (due to the diuretic effect) while large quantities can induce tremors, hyperactivity, respiratory failure and cardiac arrest.

Onions

An extremely common pantry item, onions contain thiosulphate, which is highly poisonous to dogs and causes hemolytic anemia - the destruction of red blood cells. Onions (and their close



blood transfusion may be needed.

Note: Garlic also contains thiosulphate, albeit in much smaller quantities therefore a very large amount would need to be ingested to cause an adverse affect. Small amounts of dried garlic can actually have a positive effect on your pets health.



Xvlitol

Xylitol is type of artificial sweetener commonly found in sugar-free chewing gum and baked goods. Ingesting xylitol can stimulate the pancreas to secrete insulin, causing a rapid drop in blood sugar levels (hypoglycemia) and in large amounts can cause fatal liver damage. Symptoms of xylitol poisoning include disorientation and seizures, which can occur within 30 minutes of consumption.

Caffeine

Along with the usual suspects (coffee, tea and soft drinks), caffeine can also be found in some medications. Dogs are more sensitive than



humans to the effects of caffeine and ingestion of a moderate amount (such as coffee grounds) can cause damage to the heart, lungs, kidneys and central nervous system. Symptoms of caffeine poisoning include hyperactivity, vomiting, staggering gait, muscle tremors and convulsions.

Macadamia Nuts

Although the macadamia nut poisoning is not usually fatal it can cause uncomfortable



symptoms in dogs including weakness, drunken gait and joint swelling within 6-24 of consumption.

Human backpack, tent, sleeping bag, sensible footwear (hiking boots recommended), sunscreen, hat, insect repellent, first-aid kit, warm & waterproof clothing (the weather can be unpredictable), rubbish bags & 3-4 days of provisions for you and your dog.

For your dog: Sturdy lead & collar, canine backpack, towel, weight for the backpack, 3-4 days of food, water & water bowl, first-aid items.

Australians take dog sledding from the snow to the bush

Friday 4 July 2014 Ann Jones

Huskies, Malamutes, sleds and mushers: it sounds like something straight out of the Alaskan backwoods, but it's all happening in rural Victoria. **Ann Jones** meets the men, women and dogs who've taken an unlikely sport into the Australian bush.

The dogs are excited. They are yelping, barking, panting and straining against the harnesses. Four beeps sound, with a fifth at a higher pitch, and two dogs burst over the line, strapped together. Behind them, a woman is dragged along.

She's on a large scooter and squeals excitedly as the straps that connect the scooter and the dogs stretches taught.

'Come on puppies! Come on puppies!' she calls, piercing the early morning bush air with her screams.

Her right foot smacks the ground, making a thump when it makes contact, and when it sails forward to prepare for the next scoot it's almost as if it moves in slow motion.

This is dog sledding: Australian style.

We are in a bush plot, a scout camp, in Kialla, northern Victoria.

There are 180 adult competitors here, along with the peewees (child competitors). They have brought at least 450 dogs along with them, and the noise is phenomenal.

The dogs are tied on lines, just as you would expect to see in a photo of sled dogs in Alaska or the Arctic Circle, except that here they are standing on the fragrant, moist earth and leaf litter of the bush. The dogs bow-wow, howl, bark, and the energy level is higher than I have ever experienced at a sporting event.

The competitors and their dogs have made their way from South Australia, New South Wales, the ACT, Queensland and even Tasmania to compete in the dry land sled races.

There are a number of different types of race going on over the weekend: teams of eight, six, four, three and two dogs pulling a rig through the bush, and smaller teams and individual dogs pulling a scooter the size of a mountain bike with big wheels.

Then there is bikejoring, where the dogs actually pull the human on a bike and also canicross, in which the owner runs along with their dog, attached at the hip with a harness.

Daniel Dutch runs a three dog team as well as the canicross.

'The three dogs—they're on a rig that's kind of like a chariot,' he says.

'[There are] two small wheels at the back and a bigger one, and you basically stand on it, with basic steering like a bicycle.'

'You do a bit of running with the three dogs, you've still got to help them out. They're the transition class from the two wheel scooter and the rig, so it's a bit heavier for them to pull along, so you still have to do a fair bit of work to help them out still.'

The chariot weighs about 10 kilos, but Dutch says it's the lightest going around.

'We do weight pull with our guys as well, and they pull up around the 600kg mark with that.' 'Our guys are all around the 18 to 19 kilo mark, they're pretty lean, mostly muscle.'

'I think it ends up at about 20 times their weight, weight to weight ratio,' he says.

Dutch also runs with a seven year old boxer-cross in the canicross. The dog was an adult when Dutch entered the sport and didn't like having the large rig following her along. 'She really enjoys the canicross, she kind of gets to free-run. She started from when she was about five I think, but she gets out there with the canicross and has an absolute ball.' Dutch and his boxer-cross averaged just over 13 kilometres an hour over three kilometres in the race.

Every time the starting clock beeps, it sets another team off into the bush and another set of howls through the camp.

'Hike, hike, hike, hike!' calls a racer whizzing past.

'Hike' is one of the words that you'll hear all around the race course, and it basically means 'get going'.

The person who is running behind the dogs, or riding along on the scooter, is called the musher and there are a swathe of words used to steer and control the dogs.

'I think "gee" and "haw" came about because they sound distinctly different for the dogs, where left and right can easily be confused,' says Darren Scragg, president of the Australian Sled Dog Sport Association.

'The other major command is stop, obviously we've got stop and stand, and "on-by".' 'So if you come to a corner, or an interaction where you don't want them to turn, you use on-by. You hear a lot of people screaming "no" and "leave it", but that might be because a kangaroo goes in front of them or birds or something like that.'

Mushers certainly have their own way of communicating with their dogs, used in conjunction with these traditional commands.



'Some people make funny noises, sing to their dogs,' says Scragg. 'It's actually best not to say much, you want them to be motivated for their own reasons, and run. But hike, mush and then people make gurgling kookaburra noises and sing to their dogs and high pitched sort of squeals, whatever works.'

'When you see puppies getting trained—that's the most interesting because they can only hold concentration for a short period of time. You just need a butterfly to float across their head and they're off into the forest or into the bush.'

'Overseas they can hook up as many as 16 to 20 dogs,' says Scragg. 'The dogs are a long way in front of you, you know, so you've got to call you turns very, very early.'

The safety and wellbeing of the environment, dogs and mushers is protected by a lengthy set of rules, including harnessing regulations.

Shellie Shewring, secretary of the Northern Victorian Sled Dog Club says that the dogs are protected by a section of stretchy bungee strap built into the harness.

'The harnesses are actually designed so that they can pull through safely so that they don't do any injuries,' she says.

'The line that's actually attaching them to the scooter, it's got a bungee on it, so it stretches and takes a bit of the pull. You'll find a lot of them will actually pull it right to the end—that's to stop any jarring to the body as they're pulling through, gives them a bit of leeway so that they're not tugging all the time.'

The dogs will run their hearts out, and this is a cause for concern for owners and race organisers. It's lead to strict temperature and humidity controls on races, as the spitz breed dogs, like malamutes and huskies, can overheat easily in the Australian climate. They have a double coat (an under-layer and a guard layer) which is meant for arctic conditions. To ensure that they don't injure themselves, races are run at night and in the early hours of the morning. 'We do dry land racing, and the other form of the sport is snow racing,' says Scragg, who actually travelled to North America to learn how to control large teams of dogs on the snow. 'A lot of people have a romantic connection with that Alaskan wilderness and the big races in the United States.'

'If you want to compete with the best, you have to go to North America or Scandinavia,' he says.

For now, the dogs and their owners are preparing for a full winter season of racing in Australia. Some teams are off to an excellent start, averaging speeds as high as 32 kilometres an hour around the course.

The mushers say that it feels like you are flying.

'It is amazing,' says Shewring. 'One of those runs I did with the malamute club many many years ago, which was a 16 kilometre run; we'd run about 10 kilometres I think, so the dogs were nice and steady in their pace, just chilling. I think about 200 metres up the track a whole herd of kangaroos came through the track and the dogs just took off. I was flying, I was absolutely hanging on for dear life and I had the biggest grin on my face. It was amazing, it is so much fun. So much fun.

'It's amazing the feeling.'

Scragg agrees that it's the most fun possible on paws and wheels—which is why he's been doing it for almost 20 years.

'The good thing is that it gets you out into nature. We're running around a beautiful stuffed red gum field, you know, 20 kilometres outside of Shepparton, a lot of our places take us to beautiful parts of the world,' he says.

'The good thing about this sport in particular is it's a way for a dog to vent its natural energy. It uses a lot of energy and they go home tired and relaxed. I mean, I hope that you've noticed that most of the dogs here love it.'

'For these sorts of dogs, like my Siberians, that's what they're bred to do, but as you see with the hounds and the cross breeds, they love it too. They get to go out with their owner, who feeds them and loves them, and run around a track as fast as they can.'

It's hard to tell who is happier—the dogs, or the dog people.

3 Medications You Should Never Give Your Dog

Pets are a lot like kids. They depend on you for their safety – and you can never be too careful. Your most important job as a pet parent is to keep your pet healthy. So today, I want to give you some information about toxic medications that could potentially save your dog's life. Just because a medication is safe for humans DOESN'T mean it's safe for dogs. I've seen cases where pet parents with the best intentions accidentally poisoned their

dog with common over-the-counter medications because they didn't understand the dangers. That's why you should NEVER give your dog medication without first checking with your veterinarian.

Here are 3 common over-the-counter medications that you should NEVER give to your dog:

- 1. Aspirin Aspirin interferes with platelets (which help the blood to clot). So if your dog has a wound or laceration, aspirin would make it harder to stop the bleeding. Aspirin is especially dangerous when mixed with other drugs, like steroids or nonsteroidal anti-inflammatory drugs. Dogs may experience gastrointestinal problems, respiratory difficulties, neurological problems, bleeding disorders and kidney failure.
- 2. Ibuprofen This over-the-counter medication is a popular way to treat pain and inflammation in people – but for dogs, ibuprofen can easily exceed toxic levels. Well-intentioned owners may give their dog what they consider to be a "safe dose" – but it can easily lead to bleeding stomach ulcers and

eventually kidney failure. And, if left untreated, this can be fatal. Symptoms include poor appetite, vomiting, black tarry stools, vomiting blood, abdominal pain, weakness and lethargy.

3. Acetaminophen - Medicating your dog with acetaminophen without consulting a veterinarian is dangerous. (Pets also consume tablets that are dropped on the floor or left around the house.) Dogs are less sensitive to acetaminophen than cats are. For example, a 50-pound dog would need to ingest more than seven 500 mg tablets to suffer

toxic effects. For a cat, one 250 mg acetaminophen tablet could be fatal. If you suspect that your dog has ingested a toxic amount of acetaminophen (one pill or more), contact your family veterinarian or local veterinary emergency facility immediately. Common brands of acetaminophen include Tylenol®, Percocet® and aspirin-free Excedrin® among others. So remember to keep all medications out of your dog's reach and NEVER give your dog any medication without first consulting your veterinarian. If you ever suspect that your dog has ingested any of these medications (in any amount), please contact your family veterinarian or local veterinary emergency facility immediately. I hope this helps keep your dog safe from common medications that can be dangerous.

So Your Dog Doesn't come when called!

We know that a reliable recall is important - your dog coming when called could be the difference between them staying safe or being in danger! While most people prioritise teaching a reliable recall, many struggle with achieving success. Although a seemingly simple exercise, the recall can be the most difficult to teach- the good news is, it doesn't have to be any longer!

So why does teaching a recall seem more difficult than teaching other obedience exercises?

- The environment is too distracting for the dog's level of training
- The dog is provided with opportunities to self-rewardrunning away to play with dogs or other people for example
- Frustration and high levels of excitement are reinforced- the dog pulls on the lead all the way to the park and is immediately let off lead
- Lack of conditioning- the dog doesn't have any association with the command being used
- Dog desensitised to owners repeated commands
- Dogs are socialised in a way that develops a high value for other dogs- large amounts of uncontrolled, high energy play with other dogs tends to create problems with the development of a recall command
- Breed instincts not in line with a natural reliable recall- some dogs find it more difficult, often those that have been bred to work independently of people or who are extremely sociable.
- · Limited access to off lead areas
- · Less exercise provided than required

What is Classical Conditioning?

Classical conditioning is a pairing exercise where something that is initially neutral to the dog, is paired with something the dog naturally finds appealing - such as food. So for example, when you pair a food bowl with food a number of times, the dog becomes excited at the presence of the food bowl- even if there is no food currently in it. Imagine if you could get that type of response to a recall command! The good news is, you can!

What if my dog is not motivated by food or toys?

Every dog is motivated by food- they can't survive without it! However, for those dogs who are not motivated enough to want food additional to their meals, you may want to use their meals during training for the time being. Special drive rewards can also be used for some dogs- rabbit fur tugs, raccoons tail toys etc.- these are particularly beneficial for prey driven dogs who want to go chasing rabbits instead of returning to you!

Is my dog too old for this kind of training?

No dog is ever too old! However, if the dog has been practicing the behaviour for a long period of time, the conditioning process will take a little longer or require more repetitions than if you were to start with an 8 week old puppy.

The 10 Step Program for Teaching the Elusive-Reliable Recalls

Prevent the dog from self-rewarding when running away. This
may mean putting the dog on a long line in the park or
walking the dog more on lead during the training process.
Care should be taken to ensure the dogs exercise level does
not decrease during this time.

 Find the dog's motivator- food or a toy will generally be needed and both should be utilised where possible.
 Deprivation schedules may be needed to increase value for the motivator in the early stages of training.

- 3. Choose a recall word that has not been tainted before to use for the 100% reliable recall- this will be your emergency recall. The dog's name (or another word if you would prefer) will also be used for the training process. This method develops one informal recall (to be used regularly) and one formal recall (to be used less frequently) which is to be absolutely reliable.
- 4. The Name Game- Calling the dog's name ONCE only, when the dog makes eye contact, mark with either the word "yes" or a clicker and immediately food reward. This exercise should be repeated at least 25 times per day. For those wanting quicker or more reliable results, increase the number of repetitions of the exercise. Continue the Name Game throughout the remaining 6 steps of the Reliable Recall program but you may decrease the number of repetitions to 10 after the first 2 weeks.
- The Emergency Recall- After a few days of the Name Game only start to condition (pair with food) the Emergency recall at home. Remember to use the word only once and deliver the reward regardless of what the dog does.
- Gradually increase the level of distraction. Only move to a new level of distraction when the dog has done 5 repetitions where they immediately turned their head upon hearing their ER word.
- Start to move locations in and around the home (particularly around the front door if the dog would tend to race out the door previously)
- 8. Play hide and seek within the house, using the ER once and providing the dog with a jackpot reward when they find you. Make it easy to begin with and gradually increase the level of difficulty- this encourages the dog to be persistent and builds frustration. Building frustration often helps to increase the speed of a recall. The faster the recall, the more reliable it is likely to be. Puppy in the Middle is also a valuable game to play with any dog learning to recall but does require 2 handlers.
- With the dog on lead begin using the ER on walks and in other distracting situations. Remember to reinforce EVERY time the ER word is used. Jackpot rewards can be used for the exceptional responses from the dog.
- 10. In outside environments, begin to increase the distance away from the dog. When increasing distance, start with low level distractions and gradually increase. Distraction, duration and distance should be gradually increased- but care should be taken to separate these to start with.

- to change VCA membership requirements for non-Executive Committee members in accordance with VCA rules
- to make the format and wording of the AMCV Club Rules more consistent with the "Consumer Affairs Victoria Model Rules for an Incorporated Association" (Model Rules)*.

The following proposed changes to the AMCV Club Rules are to be voted on by the Members at a Special General Meeting to be held on Thursday 4 September at the Bulla Exhibition Centre, United Lane, Bulla. Should this meeting not reach a quorum, the changes to the club rules will be tabled at a Special General Meeting to be held on Thursday, 9 October 2014 immediately preceding the Annual General Meeting. Note: The corresponding clause in the current AMCV Club Rules is included in italics where applicable.

All references to the 1981 Act to be changed to Motion:

"Associations Incorporation Reform Act 2012".

Motion: All references to Clause and Sub-clause to be changed to Rule and Subrule respectively in line with terminology

used in the Model Rules.

That Rule 2 "Purposes" be added to the AMCV Club Rules in accordance with requirements of The Act as follows:

Purposes

The purposes of the association are

- to affiliate with the Victorian Canine Association (VCA) Inc.;
- to promote and encourage the breeding of pure bred dogs and in particular the Alaskan Malamute.
- to promote and raise the standards and exhibition of registered pure bred dogs, particularly the Alaskan Malamute.
- to promote the holding of Exhibitions under the VCA Inc. Rules and Regulations and to conduct Exhibitions and/or to promote Obedience training and to conduct Obedience training and to conduct Obedience Trials, Tracking Tests, and Field Trials;
- to foster, promote and protect the interest of exhibitors of dogs at exhibitions and particularly the exhibitors of Alaskan Malamutes
- to collect, verify and publish information relating to dogs and the breeding and exhibition of dogs;
- to educate and encourage members, breeders and judges to abide by the requirements and standards approved by the VCA Inc. for the conduct of Exhibitions and Shows;
- to promote good fellowship and sportsmanship amongst members and those participating in or attending at Exhibitions and Shows;
- (i) to inform members of and make known to them the Laws and Regulations of the State relating to the ownership and care of dogs, and the responsibility of owners for the conduct and actions of their dogs;
- to hold functions and lectures relating to dogs and to the purposes of the Club generally;
- to provide awards and donate prizes for competition at Exhibitions and for the competition by breeders and exhibitors of dogs;
- to foster relations with other Clubs and bodies having similar aims;
- to promote and assist worthy causes, as agreed at a General Meeting of the members of the Club;
- to the invest the funds of the Club not immediately required in such manner as the members or the Committee in lieu thereof shall determine;
- to purchase, hire, lease, etc. and do such things as are conductive or incidental to promoting and achieving the purposes of the Club;
- to carry on such other activities or promote or encourage interest in the breeding, upkeep and

such other things as may be necessary or conductive

Motion: The following definitions to be added under Rule 3(1): "Interpretation" (current rule 2.1) in line with the definitions in the Model Rules (Rule 4):

Rule 3(1): INTERPRETATION

- "Absolute majority", of the Committee, means a majority of the committee members currently holding office and entitled to vote at the time (as distinct from a majority of committee members present at a committee meeting);
- "Act", means the Associations Incorporation Reform Act 2012 and includes any regulations made under that
- "Association", has the same meaning as is ascribed to that word by Section 3 of the Associations Incorporation Reform Act 2012 which, inter alia, includes a Club.
- "Chairperson", of a general meeting or committee meeting, means the person chairing the meeting as required under rule 19(6);
- "Committee Meeting", means a meeting of the Committee held in accordance with these Rules;
- "Committee Member", means a member of the Committee elected or appointed under Rule 28;
- "Disciplinary Appeal Meeting", means a meeting of the members of the Association convened under rule
- "Disciplinary Meeting", means a meeting of the Committee convened for the purposes of rule 22;
- "Disciplinary Subcommittee", means the subcommittee appointed under rule 20;
- "General Meeting", means a general meeting of the members of the Association convened in accordance with Part 4 and includes an annual general meeting, a special general meeting and a disciplinary appeal meeting;
- "Member entitled to vote", means a member who under rule 30 is entitled to vote at a general meeting;
- "Officers", for the purpose of these Rules, has the same meaning as is ascribed to the word "Office Bearers".
- "Special Resolution", means a resolution that requires not less than three-quarters of the members voting at a general meeting, whether in person or by proxy, to vote in favour of the resolution;
- "The Registrar", means the Registrar of Incorporated Associations.

Motion: That Rule 4: "Powers of Association" as per the Model Rules (Rule 5) be added as follows:

- **Powers of Association**
- Subject to the Act, the Association has power to do all things incidental or conducive to achieve its purposes.

training of and the general well-being and improvement of Alaskan Malamutes and to do all to carrying out the objects of the Club.

- (2) Without limiting subrule (1), the Association may:
 - (a) acquire, hold and dispose of real or personal property;
 - (b) open and operate accounts with financial institutions:
 - (c) invest its money in any security in which trust monies may lawfully be invested;
 - (d) raise and borrow money on any terms and in any manner as it thinks fit;
 - (e) secure the repayment of money raised or borrowed, or the payment of a debt or liability;
 - (f) appoint agents to transact business on its behalf:
 - (g) enter into any other contract it considers necessary or desirable.
- (3) The Association may only exercise its powers and use its income and assets (including any surplus) for its purposes.

Motion: That Rule 5: "Not for Profit Organisation" be added (as per Model Rule 6) as follows:

- 5. Not for profit organisation
- The Association must not distribute any surplus, income or assets directly or indirectly to its members.
- (2) Subrule (1) does not prevent the Association from paying a member:
 - (a) reimbursement for expenses properly incurred by the member; or
 - (b) for goods or services provided by the member: if this is done in good faith on terms no more favourable than if the member was not a member.

 Note: Section 33 of the Act provides that an

incorporated association must not secure pecuniary profit for its members. Section 4 of the Act sets out in more detail the circumstances under which an incorporated association is not taken to secure pecuniary profit for its members.

Motion: That Rule 6(1): "Minimum number of members" be added as per Model Rule 7 as follows:

6(1) Minimum number of members: The Association must have at least 5 members.

Motion: That Rule 6(2), (4), (6) & (7) (current rule 3) be amended to replace "nominee" and "nomination" with "applicant" and "application" respectively, and remove reference to "nominated" as follows:

- 6. Application for membership
- (2) A natural person owning a pure bred dog or interested in any of the activities referred to in the Statement of Purposes of the Club who is nominated and approved for membership as provided in these Rules is eligible to be a member of the Club on payment of the entrance fee and annual subscription payable under these Rules.
- (3) A person who is not a member of the Club at the time of the incorporation of the Club (or who was such a member at that time but has ceased to be a member) shall not be admitted to membership unless nominated as provided in Subrule (4) and the admission as a member is approved by the Committee.
- (4) An application for membership shall be in such form as the Committee may from time to time prescribe and shall be signed by the applicant (and the nominee where the form so provides) and lodged with the Secretary of the Club accompanied by the fees prescribed in Rule 7.

(6) Upon a nomination an application being referred to the Committee, the Committee shall determine whether to approve or to reject the application.

(7) (a) Upon a nomination an application being approved by the Committee, the Secretary shall enter the nominee's applicant's name in the register of members and upon the name being so entered, the nominee applicant becomes a member of the Club.

Motion: That Rule 6(7 b & c) regarding rejection of a membership application be added as per Model Rules 10 (3) & (4)) as follows:

- 6 (7) (b) If the Committee rejects the application, it must return any money accompanying the application to the applicant.
 - (c) No reason need be given for the rejection of an application

Motion: That subheading 12 "Disciplinary Action" be added as per Model Rules (Division 2).

Note: there is no change to the subrules relating to Disciplinary Action (current Rule 9).

Motion: That the following amendments be made to Rule 22 "Officers of the Club" (current rule 21(1)):

- a. delete "a Public Officer" in accordance with the Act, and
- b. add "each of whom shall be members of the VCA Inc."

as follows:

- 22. Officers of the Club
 - (1) The Officers of the Club shall be:
 - (a) a President;
 - (b) two (2) Vice-Presidents;
 - (c) a Treasurer;
 - (d) a Secretary; and
 - (e) a Public Officer (refer Section 26 of the Act);
 - (e) such other Officers as required each of whom shall be members of the VCA Inc.

Motion: That rule 23 "General Duties" be added in line with Model Rule 45) as follows:

- 23. General Duties
- As soon as practicable after being elected or appointed to the Committee, each committee member must become familiar with these Rules and the Act.
- (2) The Committee is collectively responsible for ensuring that the Association complies with the Act and that individual members of the Committee comply with these Rules.
- (3) Committee members must exercise their powers and discharge their duties with reasonable care and diligence.
- (4) Committee members must exercise their powers and discharge their duties:
 - (a) in good faith in the best interests of the Association; and
 - (b) for a proper purpose.
- (5) Committee members and former committee members must not make improper use of:
 - (a) their position; or
 - (b) information acquired by virtue of holding their position:

so as to gain an advantage for themselves or any other person or to cause detriment to the Association.

Note: See also Division 3 of Part 6 of the Act which sets out the general duties of the office holders of an incorporated association.

Motion: That Rule 24 "President and Vice Presidents" be added in line with Model Rules (Rule 46) as follows:

- 24. President and Vice-Presidents
- (1) Subject to subrule (2), the President or, in the President's absence, a Vice-President is the Chairperson for any general meetings and for any committee meetings.
- (2) If the President and the Vice-Presidents are absent, or are unable to preside, the Chairperson of the meeting must be:
 - (a) in the case of a general meeting—a member elected by the other members present; or
 - (b) in the case of a committee meeting—a committee member elected by the other committee members present.

Motion: That:

- a. subrules (a), (c), (d), (e) and (f) be added to Rule 25
 "Secretary" (current Rule 29) as per wording of
 Model Rule 47, and
- reference to Public Officer (current rule 29(2)) be deleted in accordance with the Act. as follows:
- 25. Secretary
- (1) The Secretary must perform any duty or function required under the Act to be performed by the secretary of an incorporated association.
- (2) The Secretary must:
 - (a) maintain the register of members in accordance with rule 8; and
 - (b) keep and maintain minutes of the resolutions and proceedings of each general meeting and each committee meeting in books provided for that purpose together with a record of the names of persons present at committee meetings:
 - (c) keep custody of the common seal (if any) of the Association and, except for the financial records referred to in rule 36(3), all books, documents and securities of the Association in accordance with rules 41 and 42; and
 - (d) subject to the Act and these Rules, provide members with access to the register of members, the minutes of general meetings and other books and documents; and
 - (e) keep and maintain all necessary records of the affairs of the club including a complete record of awards made at all exhibitions and shows conducted by the Club, where necessary; and
 - (f) perform any other duty or function imposed on the Secretary by these Rules.

Motion: That subrules 1(c), 1(d), (2) and (3) to be inserted in Rule 26 "Treasurer" (current rule 30) in line with wording of Model Rule 48 as follows:

- 26. Treasurer
- (1) The Treasurer must:
 - Make any payments authorised by the Committee or by a general meeting of the Association from the Association's funds;
 - (d) Ensure cheques are signed by at least 2 committee members;
- (2) The Treasurer must:
 - (a) Ensure that the financial records of the Association are kept in accordance with the Act; and
 - (b) Coordinate the preparation of the financial statements of the Association and their certification by the Committee prior to their submission to the annual general meeting of the Association.

(3) The Treasurer must ensure that at least one other committee member has access to the accounts and financial records of the Association.

Motion: That in Rule 27 "Composition of Committee" (current rule 24 (1)):

- (1) "Hereditary Diseases Officer" be changed to "Health Officer"
- (2) "each of whom shall be members of the VCA Inc." be deleted

as follows:

- 27. Composition of Committee
- (1) Subject to the Act, the Committee shall consist of:
 - (a) the Officers of the Club; and
 - (b) the following Committee positions: Show Secretary, Health Officer, Puppy & Referral Officer; Publicity/Education Officer, Fund Raising Co-ordinator, Sledding Co-ordinator, Weight-pull Co-ordinator, Back-packing Coordinator, Obedience Co-ordinator, Newsletter Editor.

each of whom shall be members of the VCA Inc. Note: Only Officers of the Club are required to be VCA members under VCA Rules (Rule 3.4.3.4).

Motion: That reference to Public Officer be deleted from Rule 30 "Nomination and Voting" (current rule 27) in accordance with the Act as follows:

- 30. Nomination and Voting
- (1) Unless the Club's By-Laws provide otherwise a member may be nominated for but not hold more than one position on the Committee, except for the position of Public Officer.

Motion: That subrule 10 "Use of technology" be inserted in Rule 31 "Meeting of the Committee" (current rule 28) in line with Model Rule 62 as follows:

- (10) Use of technology
- (a) A member not physically present at a Committee meeting may be permitted to participate in the meeting by the use of technology that allows that member and the members present at the meeting to clearly and simultaneously communicate with each other.
- (b) For the purposes of this Part, a member participating in a Committee meeting as permitted under subrule (10a) is taken to be present at the meeting and, if the member votes at the meeting, is taken to have voted in person.

Motion: That subrule (11) "Conflict of Interest" be inserted in Rule 31 "Meeting of the Committee" (current rule 28) in line with Model Rule 65 as follows:

- (11) Conflict of interest
- (1) A committee member who has a material personal interest in a matter being considered at a committee meeting must disclose the nature and extent of that interest to the Committee.
- (2) The member-
 - (a) must not be present while the matter is being considered at the meeting;
 and
 - (b) must not vote on the matter.
- Note: Under section 81(3) of the Act, if there are insufficient committee members to form a quorum because a member who has a material personal interest is disqualified from voting on a matter, a general meeting may be called to deal with the matter.
- (3) This rule does not apply to a material personal interest—

 that exists only because the member belongs to a class of persons for whose benefit the Association is established; or

(b) that the member has in common with all, or a substantial proportion of, the members of the Association.

Motion: That subrule (12) "Minutes of Meeting" be inserted in Rule 31 "Meeting of the Committee" (current rule 28) add in line with Model Rule 66 as follows:

31 (12) Minutes of meeting

- (a) The Committee must ensure that minutes are taken and kept of each committee meeting.
- (b) The minutes must record the following
 - the names of the members in attendance at the meeting;
 - (ii) the business considered at the meeting;
 - (iii) any resolution on which a vote is taken and the result of the vote;
 - (iv) any material personal interest disclosed under subrule 11.

Motion: That reference to Public Officer be deleted from Rule 32
"Removal of Member of Committee" (current rule 31) –in
accordance with the Act as follows:

32. Removal of Member of Committee or public officer

Motion: That Rule 35 "Source of Funds" be added in line with Model Rule 68 as follows:

35. Source of funds

The funds of the Association may be derived from joining fees, annual subscriptions, donations, fundraising activities, grants, interest and any other sources approved by the Committee.

Motion: That Rule 37 "Financial statements" be added in line with Model Rule 71 as follows:

- 37. Financial statements
- For each financial year, the Committee must ensure that the requirements under the Act relating to the financial statements of the Association are met.
- (2) Without limiting subrule (1), those requirements include:
 - (a) the preparation of the financial statements;
 - (b) the auditing of the financial statements;
 - (c) the certification of the financial statements by the Committee;
 - the submission of the financial statements to the annual general meeting of the Association;
 - (e) the lodgement with the Registrar of the financial statements and accompanying reports, certificates, statements and fee.

2014 Show Point Score Competition Rules

The competition shall run from 1st January, 2014 to 31st December, 2014.

 All Championship shows held in Victoria shall count (except the Melbourne Royal & AMCV Championship Show) and the winners will be awarded from the ten (10) best results submitted.

To be eligible for an award in the Show Point Score Competition, all registered owners of the exhibit must be current AMCV Members. Points will only be allocated if all registered owners are financial members of the AMCV at the time of the show for which results are being submitted.

- The onus is on exhibitors to send their results to the Show Secretary, no later than one (1) month after the event together with a marked catalogue, (front cover and Judge's page along with the Alaskan Malamutes fully marked) including the best of classes in breed marked with a circle or asterisk. The exhibitor submitting the results must also sign on the front of the catalogue.
- One exhibitor may send in the results for all those at a show, but all exhibitors who wish their results to be submitted for the competition must sign the front of the catalogue as some people may not wish to be included in the Point Score Competition.
- 4. There is no limit to the number of results that can be submitted, however only a competitor's ten (10) best results submitted will be published as the year progresses. Once a competitor has reached the ten (10) shows the Show Secretary will automatically adjust the points accordingly.
- A complete record of shows submitted together with catalogues will be kept by the Show Secretary in the event of any dispute arising.
- Trophies will be awarded to the registered owner/s of the winners at the time of submitting their dog's last results.
- The competition will consist of Most Successful Alaskan Malamute, Most Successful Dog, Most Successful Bitch and Class awards.
 - 7.1 Most Successful Alaskan Malamute Dog and Bitch Most Successful Dog and Bitch will be awarded to the dog and bitch which has the most points from the ten (10) best shows submitted. Points will be awarded to Challenge winners on the basis of one (1) point for each dog or bitch beaten including one (1) for your dog or bitch, to a maximum of twenty-five (25) points per show
 - 7.2 Most Successful Alaskan Malamute Most Successful Alaskan Malamute will be awarded to the Dog or Bitch which has the highest number of points from their ten (10) best shows submitted.


Points will be awarded to Best of Breed and Challenge winners on the basis of one (1) point for every dog or bitch beaten including one (1) for your own dog, to a maximum of twenty-five (25) points per show.

7.3 Class awards

Best Baby Puppy - Dog and Bitch
Best Minor Puppy - Dog and Bitch
Best Puppy - Dog and Bitch
Best Junior - Dog and Bitch

Class points will be allocated as follows: 1 point for every dog or bitch beaten in your class $1^{\rm st}$, $2^{\rm nd}$ and $3^{\rm rd}$ placings including one (1) for your exhibit, also one (1) point for every exhibit of the opposite sex if you take your class of breed, to a maximum of twenty-five (25) points per show. Example: If there are 6 exhibits shown in a class, $1^{\rm st}$ wins six (6) points, $2^{\rm nd}$ five (5) points, $3^{\rm rd}$ four (4) points. If this $1^{\rm st}$ place winner then wins its class of breed and four (4) of the opposite sex were shown, it gains a total of ten (10) points.
